


# NIGHT NATION RUN



TMT Productions, LLC Waiver and Release

In consideration of the foregoing, I, Mary Nash, for myself, my representatives, my agents, my heirs, my executors, my administrators, and my trustees, do hereby fully and forever waive, release, and discharge any and all rights and claims for any injuries and damages, including, but not limited to demands or actions for negligence, premises liability, emotional injury, intentional conduct, resulting in unintended injury or damage tort claims, and any other actions or demands of whatsoever nature, to the fullest extent permitted by law, I have or may have, whether known or unknown, against TMT Productions, LLC, the Entertainment Industry Foundation and their employees, principals, directors, shareholders, agents, members, managers, affiliates, representatives, assigns, legal predecessors and/or successors, including any subsidiaries thereof, and all sponsors of any Night Nation Run events in which I may participate, whether my participation is as a contestant or spectator of any of these events.

I acknowledge that I am aware of the inherent risks involved in these events and I voluntarily assume these risks. I attest and verify that I am physically fit and I have sufficiently trained for the completion of the above-referenced event or events in which I participate and that my physical condition has been verified by a medical doctor.

If I am participating in the Night Nation Run, I understand that the Night Nation Run is a noncompetitive event and that no racing is allowed. I further understand that the Night Nation Run involves walking/running as part of a larger group on public/ private streets where hazards exist. I assume all risk of injury or death. I ALSO UNDERSTAND THAT I should take every precaution to PREVENT SERIOUS INJURY AND I AGREE TO WEAR protective active clothing, footwear, eyewear, and any item that may prevent any injury under the circumstances, AT ALL TIMES DURING MY PARTICIPATION IN THE Night Nation Run event.

Further, I hereby grant full permission and license to any and all of the foregoing to use my name, my voice, and/or my picture in any broadcast, telecast, advertising, promotion, or other account of this event for any purposes whatsoever.

TMT Productions, LLC reserves the right to reject any entry, and further reserves the right to change the details of the above-referenced events without prior notice. I understand that my entry fee is nonrefundable and numbers are nontransferable.

I SHALL EXHIBIT appropriate behavior at all times while at the Event and obey all local, state and federal civil and criminal laws while participating in or attending the Event, including respecting other people, facilities, equipment and property. I AGREE that Event officials may dismiss me, without refund, should my behavior endanger the safety of, or negatively affect the Event. I UNDERSTAND that bag searches/security checks may be conducted by event officials at any point during the event to ensure the safety and security of participants and spectators. I UNDERSTAND that any items bring to the Night Nation Run are the responsibility of my self or guardian, and TMT Productions, LLC is in no way responsible for lost, missing, stolen or damaged items.

I INDEMNIFY AND HOLD HARMLESS THE PERSONS AND ENTITIES MENTIONED herein for any and all claims made or liabilities assessed against them as a result of (i) my actions or inactions, (ii) the actions, inactions or negligence of others including those parties hereby indemnified; (iii) the conditions of the facilities, equipment, or areas where the event is being conducted; (iv) the Competitive Rules; or (v) any other harm caused by an occurrence related to the Night Nation Run event.

**Severability:** If any provision of this Liability Waiver shall be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Liability Waiver and shall not affect the validity and enforceability of any remaining provisions.

## COVID-19 SAFETY ACKNOWLEDGMENT – LIABILITY WAIVER AND RELEASE OF CLAIMS

### Warning

### Waiver, Release, and Indemnification
